

DCM Report:

Serving as acting DCM, the following report.

"We, The District Committee of District 8, The Cowichan Valley, are an important part of the Inverted triangle of our AA Service Structure.

I was pleased to attend the online WRASSA Conference, on February 26th and 27th. This is a recurring event involving the four Regions of Western Canada, BK/Yukon, Alberta, Saskatchewan and Manitoba. Members of the service structure from all Areas, including our Area 79, spoke to us on the general topic of "A.A. in a Time of Change."

My takeaway was that the Structure is filled with dedicated people who have embraced change during the time of Covid and have adapted very well to an online world for their service work. At their level we are in capable hands. Our own BC/Yukon Area was well represented by well spoken and well prepared AAs.

My concern, right now, is very much focused on our own District 8. It is evident that between changes brought about by Covid and the normal changes that can happen in a district, it is the AA members and groups that are hurting the most. You are all familiar with the questions of personal choice of each AA, how different groups are handling change and the fact that people are indeed hurting out there. Thus, we need to get on with our Role as a District Committee.

We have five out of eleven Committee Chairs vacant and some GSRs have resigned for various reasons, so we have work to do. Recently I have seen Committee Chairs cooperating with each other to problem solve issues. It is the same with GSRs. That is very positive. We are starting to communicate more and help each other with a better understanding of each other's roles.

I feel we have the "stuff" to cooperate and fulfil our responsibilities and at the same time, and I like this recently learned phrase, stay in our own lanes of responsibility. We begin with getting names correct, ensuring group names are correct and where they should be. We will be updating meeting lists as soon as possible. I speak of detailed stuff. In addition, GSRs are mostly active now, and Committee Chairs are working to address their roles. I plan on contacting each of you before April's meeting to find out what you need or what assistance you might seek. So, it is my hope that we will continue to build the AA spirit in District 8 and do our part in our Service Structure.

Alternate DCM Position (District Committee Member)

"The Alternate D.C.M. The alternate is a backup for the D.C.M. If the D.C.M. resigns or is unable to serve for any reason, the alternate steps in. Usually, the alternate is elected at the same time as the D.C.M., by the same procedure. Alternate committee members should be encouraged to assist, participate, and share in the D.C.M.'s responsibilities at district and area meetings" (*p.s33).

The alternate DCM position is vacant. If you have four or more years of sobriety and have served as a GSR, why not give it a try?

Treasurer

<u>Duties:</u> The treasurer keeps financial records... and reports regularly....

<u>Qualifications:</u> The treasurer should be a responsible person with a solid period of sobriety. He or she should be organized enough to keep good records, and some accounting or bookkeeping experience is useful. Otherwise, the person elected may need help in setting up a system, and possibly some clerical assistance. Persuasiveness, firmness, and diplomacy will help the treasurer do the job.

I got sober in Victoria, April 16th of 1982, so I just celebrated 39 years. I got involved in service early on, pretty much "voluntold" by my sponsor as a way to help other people and so keep myself sober. I worked at the 2020 Douglas St. Intergroup as secretary and have held various service positions at the group level: secretary, treasurer, and GSR.

This is my first time at the District level other than as a GSR and it has been a bit of a learning curve. It's taken me some time to get the details of the job sorted out. I contacted a bookkeeper for help with doing the spreadsheet since I don't have those skills myself. I think it is pretty well organized now.

I decided to take this position since it was vacant and it looked like there wasn't anybody else to do it, so I stepped up.

The other passion in my life aside from AA is golf. I love the game and the fact that because of it I have made so many wonderful friends. My first golf game was at March Meadows at an AA golf tournament and it was love at first tee. I enjoy the constant challenge to improve my game. It's sort of like the program; you are always going forward, learning new things. One of the things I am striving for lately is to have better balance in my life.

I believe in AA and that it's up to each of us to keep it going. I think it is important to be involved and to keep close to the fellowship. That belief has kept me sober all these years.

GSRs-The vital link

The general service representative has the job of linking his or her group with A.A. as a whole. The G.S.R. represents the voice of the group conscience, reporting the group's thoughts to the district committee member and to the delegate, who passes them on to



the Conference. This communication is a two-way street, making the G.S.R. responsible for bringing back to the group Conference Actions that affect A.A. unity, health, and growth. Only when a G.S.R. keeps the group informed, and communicates the group conscience, can the Conference truly act for A.A. as a whole.

Qualifications

- Experience shows that the most effective G.S.R.s have been active in group, intergroup, or other service, where they have developed a desire to serve, and encountered situations in which the Twelve Traditions have been called upon to solve problems.
- Usually, prospective G.S.R.s have at least two years of continuous sobriety.
- They have time available for district meetings and area assemblies.
- They have the confidence of the group, and an ability to listen to all points of view.

Duties

- G.S.R.s attend district meetings.
- They also attend area assemblies.
- G.S.R.s supply their D.C.M.s with up-to-date group information
- They participate in district and area service meetings, and often help with planning for area get-togethers and conventions. Following these events, they make reports to their groups for the benefit of those who could not attend (*p. S26).

Your GSRs:

Hump Day United

I am currently the GSR for Hump Day united. I was the GSR for the Sunday morning Discussion Group in White Rock, where I was Living for the past 4 yrs. I came back to the Cowichan Valley full time just over a year ago. I have been working in Crofton for a Company on and off for 29yrs. We service the oil and gas and Pulp & Paper industries. I grew up here in the valley and have 2 daughters and I am a grandfather to one boy.

I love the service position as GSR as I get to learn how the message is carried. Thank you for allowing me to be of service.

Wednesday Women: Heart to Heart

I have been sober for 28 years now and that is a gift. I got into service work because I was shown by an old timer how there are different forms of carrying the message: everyone has something to offer, even a newcomer.

I think the job of GSR is important because it's about connection with other AA groups and helping each voice being heard on issues that affect our fellowship.

The on-going change in my life by doing service is working on finding my voice, which has long been silent prior to recovery. There has been growth in my own understanding that the message is kept alive by sharing it, not hoarding it.

I want to do it because learning to cultivate a practice of compassion can only grow with interaction with others.

Chemainus

I sobered up on Saanich peninsula in 1980. I moved to Winnipeg shortly after, commencing service work, and then to Williams Lake, BC in 1986. In Williams Lake, I furthered my service work, becoming a GSR for a group. We retired in 2013, and from then on spent part of the winter with my family on Vancouver Island, with my wife and I staying in our RV in Chemainus. In June 2020, we moved to the Cowichan Valley, and I volunteered for a service position with the Chemainus group, and became their GSR. I have found that service work is rewarding, and is part of the triangle of unity, service and recovery. I encourage all to participate in service work.



Courage to Change

Having arrived at the starting point on June 20th 2019-I started attending regular home group AA meetings in Mill Bay-where I live with my family (wife, 7YO daughter, twin 3YO boys, a large Great Pyrenees dog named Hollis, a Bengal cat named Gibo, a Maine Coon cat named Sassernach, and two lion-headed bunnies).

As an Alternative GSR from September-December 2019, and then a GSR from January 2020-present, it really has been a 'stop-start' role. On one hand, the role of a GSR is that of an interlocutor-between news and information sharing or seeking at the District level and back down to the home group level, and the other being a consensus builder at the home group and District level. From the time that I have been involved, membership has dwindled-from averaging around 12-10 to 3 or 4 at the moment, if that.

I have really enjoyed my participation at the District level and at least being the purveyor of info for those willing to attend. I can only hope that membership picks up, allowing for new (and older) members to return. With the arrival of Covid vaccines, it is hoped that MB C2C will see an increased attendance, allowing for fulsome meetings to occur and actual District-level info to be shared, vetted, and discussed.

Saturday Morning Women (and Sisters of Sobriety)

I celebrated my 10 years of sobriety on Sept 27, 2010, after being an Al-Anon member for many years. I believe it was a miracle! As part of completing a set of steps in Al-Anon, I was asked to read "The Doctor's Opinion" from The Big Book to understand the alcoholic better. The rest is history. I experienced an ah ha moment, and after nearly 40 years of trying to control my drinking, I joined A.A.

My experience in A.A. is best described by Mark Twain's famous quote, "When I was a boy of 14, my father was so ignorant I could hardly stand to have the old man around. But when I got to be 21, I was astonished at how much the old man had learned in seven years." I questioned many things when I first joined the fellowship. I frequently wondered if I belonged. I was confident I could improve on the big book's language and the repetitive nature of our meetings. I stayed, and over time as I listened and witnessed transformation after transformation, I became both humbled and astonished at the program's wisdom.

I got into service because someone asked me, and no one else was available. I felt I both didn't have the time and was inadequate for the job; and yet, I believed that if I wanted to continue to benefit from the program, I needed to "suit up and show up." It has been a game-changer for me. I have gained far more than I have given. It has helped me reach out for help, connect, strengthen my program, and learn more about the wise ways our program works to support me to stay sober and help the still-suffering alcoholic. I hope you won't wait as long as I did to reap the gifts of service.

NEW BUSINESS:

COMMITTEE REPORTS:

Cooperation with The Professional Community: Chair reported that District 8 CPC Committee is now registered with Area 79 and GSO. We are connected (via Zoom) with other CPC District Chairs through a monthly joint meeting which is hosted by Area 79 CPC Chair. This allows us to share experiences and resources. We will be participating in an

<u>Grapevine</u>: Chair reported that a couple new books will be available in April via the Grapevine. The books are "Free on the Inside" and "Women in AA" (Spanish).

Newsletter: Chair (See New Business above)

<u>Telephone Answering Service</u>: Chair reported that the Hotline went down on Monday. In the Alano Club's move to Whistler Street, the modem was disconnected. Research found that Telus could provide a cheaper package. Chair volunteered to reconnect the modem at his home and the decision to change carriers to Telus will be tabled.

<u>Treatment</u>: An accessibility survey is in the works. Please invite anyone with a disability to participate in a meeting to discuss the survey. Currently, there is no meeting at the Hospital. Cedars does not send folks to outside meetings, but are holding speaker meetings via Zoom(?). Chair left pamphlets at Cairnsmore and asked the staff what help we could provide. Chair is checking in with assisted living facilities as well.

Webmaster: Service opportunities are posted on the website.

GSR REPORTS:

<u>Brown Baggers</u>: GSR reported that the meeting held successful elections. They still need an alternate GSR. They start meeting in hybrid fashion on April 1. They will be celebrating 2 birthdays in April.



<u>Chemainus Wednesday Night</u>: GSR reported that they are meeting in person with about 10 people regularly.

<u>Cowichan Station</u>: GSR reported that they're meeting in a hybrid fashion, following health procedures, on Thursday evenings. First Thursday of April they will celebrate member's 35 years and 30 years.

Hump Day United: GSR says that the meeting is going well. They are meeting in a hybrid fashion with 12-18 people attending per meeting. They have a new treasurer.

Quamichan Step Study: Alt GSR reported. The group is meeting on Thursdays at 7 pm via Zoom. When it gets warmer they hope to meet outside. They read the "12 and 12," and discuss the Traditions on first Thursdays. Three upcoming birthdays. They have 9-12 people attending meetings and enjoy out of town visitors.

<u>Saturday Morning Womens'</u>: GSR reported that 6-9 people attend the Saturday in person meeting. The group has also started a Thursday evening Zoom meeting called Sisters of Sobriety (below).


<u>Sisters of Sobriety</u>: This group has been meeting online on Thursdays at 7 pm. Regularly 12-15 people attend. Someone volunteers to bring a reading to the meeting to inspire the discussion.

Stepping Stones: GSR reported that Wednesday 7:30 pm on Zoom. They average about 21 people attending. They celebrate birthdays at the first of the month.

<u>Traditionally Yours</u>: GSR reported that they meet at 2 pm on Sundays in person with about 8-12 people regularly attending. They will celebrate a birthday this month.

Wednesday Women Heart to Heart: GSR reports that Heart to Heart Women's Discussion meets in person Wednesday at 1:30 pm, St. John's Anglican Church, Duncan. Masks are worn at all times, and have well-spaced chairs with tables. Attendance is 6 to 12 women. A random reading from daily reflection is read and discussed. April 21, GSR is taking 29 years, this meeting will be an open meeting to everyone, yes that includes men.

<u>Saturday Morning Men's Meeting:</u> GSR reported that they meet Saturdays at 9:30 am via Zoom. They are going to register this meeting, once they get an address.
